

CONTRACT FOR INTERVIEW AND/OR PRODUCTS SERVICES

This agreement ("Agreement") constitutes a binding contract for interview services and/or products. By signing this Agreement, the client, identified on page two and three (if applicable) of this Agreement (henceforth, referred to below as "the Client") agrees to pay Life. Documented, LLC (DBA: "Life. Documented") for interview services and/or products provided by Life. Documented, LLC at the price set forth on the day of filming.

The following terms and conditions shall also apply to the Client's engagement of Life. Documented, LLC:

PAYMENT. The Client understands and agrees that the entire amount owed for interview services and/or products, as specified at the day of filming, is due on the day of filming.

VIDEO INTERVIEWS, DIGITAL FILES, PRODUCTS and COPYRIGHTS. Video interviews, digital files and/or products produced by Life. Documented, LLC are protected by Copyright Law and may not be reproduced in any manner without explicit written permission by Life. Documented, LLC.

CREATIVE CLAUSE. Life. Documented, LLC is granted full editorial, production, and content control by the Client regarding all aspects of production and post-production services. In the case a particular segment of an interview is either not recorded, partially recorded, or not a part of the [final] edited master disk/digital, it is at the sole discretion of Life. Documented, LLC as the exclusive producer of the interview. If something occurred in the interview that the Client does not want to appear on the [final] edited master disk/digital, the Client must instruct Life. Documented, LLC immediately after the interview's recording. Any requests for changes to the [final] edited master disk/digital, will be made at the current rate per hour for editing and labor (\$85). Life. Documented, LLC retains the exclusive right to edit and re-edit all recorded video.

NON-GUARANTEES. Although care will be taken to produce a high quality video interview of lasting importance, Life. Documented, LLC cannot place an unconditional guarantee on the above. Life. Documented, LLC will not be held responsible for interviews ruined by causes in or outside of Life. Documented, LLC's control.

PERFORMANCE. The performance of this contract on behalf of Life. Documented, LLC shall be contingent upon acts of nature, flood, fire, warfare, government laws or regulations, electrical failure, strikes by suppliers, and/or conditions beyond its control.

VENUE, ATTORNEY'S FEES AND APPLICABLE LAW. The validity and interpretation of this Agreement shall be construed in accordance with the laws of the state of Georgia. Any court action to enforce this Agreement, or relating or arising out of this Agreement, or the services provided

by Life. Documented, LLC, shall be brought in a court of competent jurisdiction in the County of Gwinnett, State of Georgia. In any action, arbitration or other judicial, quasi-judicial, or extra-judicial proceeding related to any dispute arising from this Agreement, each party to this Agreement shall bear their own attorney's fees. In case any provision of this Agreement shall be invalid, illegal, or unenforceable, such provision shall be severable from the remainder of this Agreement and the validity, legality, and enforceability of the remaining provisions shall not, in any way, be affected or impaired thereby. Unless otherwise provided herein, this Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, beneficiaries, successors and assigns. Each party represents that all required authorizations for its execution of this Agreement necessary to make this instrument binding in accordance with its terms against such party have been obtained and are in effect.

PARENT/LEGAL GUARDIAN AGREEMENT. If interview services rendered involve a minor, the Client must be present during the minor's interview. Life. Documented, LLC and the Client both agree that, unless such accompaniment takes place, an interview cannot—and will not— occur.

Note: No more than one minor is permitted in the studio at a time. It is recognized that occasions arise where the Client may have other minors with him or her, as in the case of a mother having other children in tow. In such cases, the Client must bring another adult with him or her to chaperone the minors in the studio lobby while the interview proper is being conducted.

AMENDMENTS. This contract has been freely negotiated and shall be recognized as the entirety of the agreement. Only those changes or modifications specifically placed in writing, attached, dated, and signed by the Client and Life. Documented, LLC at the time of acceptance of this Agreement shall be recognized as amendments to this Agreement.
